1% Manual Tally

Per Elections Code Section 15360, 1% of precincts must be hand tallied to determine that the voting system is reading and tabulating votes correctly. To determine 1% of the precincts, divide the total number of precincts including mail ballot precincts, by 100. For November 3, 2020, there were 72 precincts, which means that .01 or 1 precinct must be fully counted. Additionally, one precinct must be counted for each contest that is on the ballot. As such, additional precincts are randomly selected for each contest that is not included in the initial count. For November, 2020, twelve additional precincts were tallied for individual contests. Votes cast in those precincts listed below were tallied including Vote-By-Mail ballots and Vote Center Ballots.

Precinct 1315 (100%)

Vote by Mail Ballots: Balanced on first pass.

Vote Center Ballots: Balanced on first pass.

Precinct 1004 Contest:

Vote by Mail Ballots: One contest was tallied. Balanced on first pass.

Vote Center Ballots: One contest was tallied. Balanced on first pass.

Precinct 1308 Contests:

Vote by Mail Ballots: Two contests were tallied. Did not balance on first pass.

It was determined that 1 ballot was mis-sorted and count balanced on 2nd pass.

Vote Center Ballots: Two contests were tallied. Balanced on first pass.

Precinct 2001 Contest:

Vote by Mail Ballots: One contest was tallied. Balanced on first pass.

Vote Center Ballots: One contest was tallied. Balanced on first pass.

Precinct 2003 Contest:

Vote by Mail Ballots: One contest was tallied. Balanced on first pass.

Vote Center Ballots: One contest was tallied. Balanced on first pass.

Precinct 3200 Contests:

Vote by Mail Ballots: Two contests were tallied. Balanced on first pass.

Vote Center Ballots: Two contests were tallied. Did not balance on first pass. It was determined that a batch of ballots was not tallied. Batches and counts confirmed and precinct balanced on 2nd pass.

Precinct 4204 Contests:

Vote by Mail Ballots: Two contests were tallied. Balanced on first pass.

Vote Center Ballots: Two contests were tallied. Balanced on first pass.

Precinct 5400 Contests:

Vote by Mail Ballots: Three contests were tallied. Did not balance on first pass. It was determined that a batch was not included on first pass. After batches were verified, counts were confirmed and balanced on 2nd pass.

Vote Center Ballots: Three contests were tallied. Balanced on first pass.

Precinct 5403 Contests:

Vote by Mail Ballots: Two contests were tallied. Did not balance on first pass. It was determined that a ballot was mis-sorted. Ballot was located and tallied and counts confirmed and balanced on 2nd pass.

Vote Center Ballots: One contest was tallied. Balanced on first pass.

Precinct 5425 Contest:

Vote by Mail Ballots: One contest was tallied. Balanced on first pass.

Vote Center Ballots: One contest was tallied. Balanced on first pass.

Precinct 5430 Contest:

Vote by Mail Ballots: One contest was tallied. Did not balance on first pass. Batches verified and re-tallied, balanced on 2nd pass.

Vote Center Ballots: One contest was tallied. Balanced on first pass.


Precinct 5432 Contests:
