

IMPARTIAL ANALYSIS OF MEASURE "V"
ALVIEW-DAIRYLAND UNION SCHOOL DISTRICT BOND MEASURE

This impartial analysis of Measure V ("Measure") has been prepared by County Counsel pursuant to Section 9500 of the California Elections Code. The Measure was placed on the ballot by the Board of Trustees of the Alview-Dairyland School District ("District"). If approved, the Measure would authorize the District to issue \$7,300,000 in general obligation bonds to fund educational facility projects for the District's schools. The proposed bonds are financial instruments used by school districts to borrow money that is repaid by a property tax levy. To pass, the Measure must be approved by fifty-five (55%) of voters who vote in the election.

Money generated by the bonds can only be used for the purposes that are set out in the full text of the Measure. These purposes include but are not limited to:

- Constructing a gymnasium or multi-purpose room;
- Replacing or repairing roofs, pipes, plumbing, sewer and gas lines, waterlines, storm drains, heating, cooling, ventilation and electrical systems;
- Improving school safety, including sprinkler and fire suppressions systems;
- Improving student security, including fencing, barriers, and communication and surveillance systems;
- Improving and equipping classrooms, restrooms, and other school facilities; and
- Making safety improvements including to walkways, pick-up and drop-off areas.

A complete list of projects is included with the full text of the Measure. Including a project on the list does not guarantee the project will be funded or completed without State matching funds, which the District states it intends to pursue.

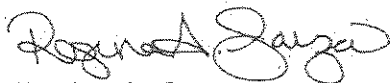
Under the California Constitution, money generated by school district bond measures cannot be used for faculty or administrator salaries and pensions, or other operating expenses. In addition, State law requires the District to conduct independent financial and performance audits annually and to establish an independent citizen's oversight committee to ensure that money generated by the bonds is used only for the projects included in the Measure.

The bonds will be repaid from taxes collected on taxable property located within the District. The amount of tax paid will depend on the assessed value of such property. The District's best estimate of the highest tax rate to be collected to repay the bonds is \$30.00 per \$100,000 of assessed value of property within the District. The District's best estimate of the total amount, including interest, that will be required to repay the bonds is \$16,088,166. These calculations are estimates only and are not binding upon the District.

If the Measure is not approved by fifty-five percent (55%) of the qualified District electors voting on the Measure, the District will not be authorized to issue bonds for the aforementioned purposes.

A "yes" vote on Measure V is a vote to authorize the bond issuance in the amount of \$7,300,000 to be financed by an annual property tax.

A "no" vote on Measure V is a vote against the proposed bond issuance.
